- I understand that if my vehicle is towed OFF-CAMPUS, I assume full responsibility for all costs involved and will pay the towing company directly at its commercial rate.
- I will comply with all additional directives that Augustana may issue and abide by the rules and regulations for parking as set out in the Augustana Campus Parking Regulations (on the website).
- I understand that while my parking permit is transferable, any change of vehicles must be reported to the Parking Services Office.
- I understand that parking privileges are a license only and vehicles shall be driven or parked on campus strictly at the risk of the owner. **University of Alberta, Augustana Campus, its employees and agents, assume no responsibility for any losses, damages, charges, or costs and are not liable for any damages incurred by or to the driver or occupants thereof.**
- I understand that a parking permit allows me to park in Student Areas/Lots IF space is available. **Augustana does NOT guarantee a space.**
