# Medical Student Exposure to Infectious and Environmental Hazards Procedure

Scope:	Compliance with this protocol extends to all members of the MD Program at the University of Alberta irrespective of the geographically distributed site at which they are located.	

## **OVERVIEW**

This procedure provides the steps required to address medical student exposure to infectious and environmental hazards or injury.

### ACCREDITATION STANDARDS

This policy addresses standard 12.8 (Student Exposure Policies/Procedures) of the Committee on Accreditation of Canadian Medical Schools (CACMS), which states:


Standard 12.8 A medical school has policies in place that effectively address medical student exposure to infectious and environmental hazards, including:

- a) education of medical students about methods of prevention
- b) procedures of care and treatment after exposure, including a definition of financial responsibility
- c) effects of infectious and environmental disease or disability on medical student learning activities.

#### **PROTOCOL**

The following algorithm applies to any injury, incident, or exposure, including: human blood/body fluid exposure or airborne exposure (e.g. tuberculosis).





- Ensure that you indicate to all Health Care Professionals that you are in contact with that this is a work-related incident (students in Alberta are considered workers for WCB purposes)
- . Ensure you receive copies of any paperwork and reports that are filled out.
- · Ensure that you have received appropriate counselling and had all questions and concerns addressed.
- . Ensure you know -- WHEN, WHERE, AND WITH WHOM to follow up.
- All injuries, incidents, and exposures MUST be reported within 48 hours to 1) the MD Program office via email (ume.hbbfe@ualberta.ca); and 2) the University of Alberta: visit www.ehs.ualberta.ca and complete the online University of Alberta Incident Report and complete the Alberta WCB Worker's Report of Injury.

Any definitions listed in the following table apply to this document only with no implied or intended institution-wide use.		
BBF Blood or Body Fluid Exposure	Blood or Body Fluid Exposure is the result of an event where a person is exposed to potentially infectious blood or bodily fluids through one of the following:  • Percutaneous exposure through puncture of skin by needlestick or another sharp object  • Permucosal exposure through contact with mucous membranes  • Non-intact skin exposure through eczema, scratches, and damaged skin	
BBP Blood Borne Pathogen	Blood Borne Pathogens are infectious microorganisms in human blood that can cause disease in humans. These pathogens include, but are not limited to, hepatitis B (HBV), hepatitis C (HCV) and human immunodeficiency virus (HIV).	
CACMS Committee on Accreditation of Canadian Medical Schools	The Committee on Accreditation of Canadian Medical Schools (CACMS) ensures that Canadian medical faculties' MD programs meet the quality expected when producing tomorrow's doctors.
